## RESOLUTION NO. 2018-01

## A RESOLUTION IN SUPPORT OF RELEASE OF BLM WILDERNESS STUDY AREAS IN HUMBOLDT, LANDER, EUREKA, ELKO, & WHITE PINE COUNTIES, NEVADA

WHEREAS, the Bureau of Land Management (BLM) designated 4 Wilderness Study Areas (WSAs) in Humboldt County (95,799 acres), 2 WSAs in Lander County (51,646 acres\*), 2 WSAs in Eureka County (39,925 acres), 10 WSAs in Elko County (272,422 acres), and 1 WSA in White Pine County (362 acres), Nevada totaling 484,990 acres. The BLM designated these WSAs without appropriate public input or reasonable federal guidelines; and

WHEREAS, the federal government has routinely been restricting access to much of Nevada through designations of national monuments, wilderness areas, WSAs, national parks, etc. The government has been withdrawing multiple use access at the rate of 182,000 acres per year since 1930 and, currently, nearly 16 million acres of Nevada's public lands, a full 23% of our state, bears some level of restriction for access; and

WHEREAS, the BLM, to a large degree, has managed these WSAs as de facto wilderness areas without congressional designations for almost 30 years ignoring local Nevadans needs; and

WHEREAS, the federal government has made no effort to address these WSAs since their 1992 designation and has no plans in the future to address them.

NOW, THEREFORE, BE IT RESOLVED that the Northeastern Nevada Regional Development Authority (NNRDA) Board does hereby support U.S. Senator Dean Heller's congressional efforts to release BLM WSAs in Humboldt, Lander, Eureka, Elko, and White Pine Counties and thereby protect access for all Americans. The Northeastern Nevada Regional Development Authority also encourages Sen. Heller and Congress to release the other WSAs throughout the West, including Northeastern Nevada. The BLM has designated 541 wilderness study areas (WSAs) throughout 12 western states totaling 12,679,399 acres. That includes 63 WSAs in Nevada totaling 2,552,457 acres.
