This plan was developed from the top down.

Will lose staff time to the RDA and shifting focus from ECEDA.

Outcome of phone conference with GOED;

The state will pay \$15,000 for a planning session.

The planning session will be held March 29 and 30, 2012.

ECEDA board decision;

Create a regional development authority- Northeastern Nevada Regional Development Authority. Send an invitation for Eureka, Lander and White Pine counties to join NNRDA equal to ECEDA's current government membership process. Eventually inviting private business from these counties to join. Begin working with County Attorney on procedure to change name and Interlocal agreements with the County and cities and all other documentation to reflect NNRDA.

In the funding cycle ECEDA needs to request additional money, not less than \$75,000 with no maximum cap.
