


Silver Lion Farms




NNRDA staff spearheaded another successful “Winnemucca Futures,” an event that provides the general public, business owners, and government officials a basic overview of the County’s economic environment. A diverse panel of speakers presented on achievements, current developments, and the forecast for the future while fielding questions from the audience. This year was the biggest event yet with nearly 200 in attendance. Feedback from the event was extremely positive with other counties inquiring about the same type of event in their community. NNRDA is currently working to develop the same kind of event throughout the various NNRDA counties.



For the first time in its history, NNRDA single handedly organized and hosted an international trade mission into the region. In March, members of the Sudbury Area Mining Supply & Service Association (SAMSSA) descended upon Northeastern Nevada to gauge the market and determine if our region would be a good fit for their companies. Delegates of the Northern Ontario Trade Mission were able to visit multiple mine sites in Lander, Eureka, White Pine, and Elko Counties, as well as, participate in the Elko Reverse Expo further strengthening the relationship that exists between our two world class mining districts. NNRDA is happy to report that the City of Ely has once again partnered with NNRDA by placing membership within the organization. NNRDA is grateful to be working with the leadership and citizenry of the city of Ely and look forward to making great things happen in that historical community.

This quarter, NNRDA launched its new website in an effort to provide a contemporary look that is user friendly and contains tools that will allow site selectors and
