2) Review and discussion regarding prison populations within "Certified Population of Nevada Counties, Cities, and Towns" estimates and their effect on Public Members annual fees.

NO ACTION TAKEN. It was brought up that NNRDA uses the population numbers that the state demographer gives to calculate yearly membership dues which includes the prison populations. It was asked if this is standard procedure as it affects some communities more than others. Madison Mahon brought up the fact that the City of Carlin utilizes the prison workers for projects which has been beneficial for them. Layla Walz stated that the City of Wells is in a unique situation as they fall under the Elko County umbrella. She feels we need to know what we are talking about before making a decision. Vince Mendiola asked if it would include other entities such as local jails, detention centers, etc in the respective cities/counties? Sheldon let all know that this is where it could become a slippery slope if we try to exclude certain areas of the population. It could be a difficult task to keep track of such numbers. Rebecca Darling, as Chair, asked if we needed to table this topic and bring it back to a later meeting giving the Board Members time to research what effect it would have on a community level. Michelle Beecher feels we should table this as well because White Pine County is not in attendance today and she's sure they would like to weigh in on the conversation. Sheldon can send the numbers to everyone and we will continue the conversation at a later meeting.

G. REPORTS

1) Status Report and Leads: Staff will provide status on various activities, projects and leads. Sheldon Mudd began with lead numbers. NNRDA has 8 leads with another 20 that we'd classify as inquiries, then another 10 that would be considered low priority. Sheldon asked Jan Morrison to give an update on her area. Jan let the board know that there's an amazing project on the horizon in Pershing County that she and Heidi have been working on. They cannot give specific details but can say that it's AG related – NOT mining! The estimated capital investment is half a billion dollars with an estimated employee count of 300-500.

Sheldon continued on, since the first of the year we have begun an aggressive digital campaign, hosting Eric Kleinsorge, CEO of WEDA (World Economic Development Alliance) traveling roughly 1,200 miles in 3 days visiting our entire region. We feel he got a good, boots on the ground view of Northeastern Nevada, our industry and our culture. We held several meetings in each area and are ready to tackle the next step. We have Winnemucca Futures coming up on January 30th. Jan has worked very hard putting this together and it's expected to be another huge success.

We've been working on the Interlocal Agreement and have multiple attorney's that have to sign off on this, and we have so many comments for changes that it's now to the point that we need to start from scratch. Sheldon plans on seeking direction from the Elko County attorneys.
