### G. REPORTS

- Discussion: Sheldon thanked the board for their flexibility while he dealt with his family emergency at last months' meeting. The Lander County Rail Park has been working on a developmental concept which has been completed and approved with Union Pacific RR. There are a few more hurdles to cross but will soon to be listed as a focus site on Union Pacific's focus site website. The only other focus site remotely close in Nevada is in Fallon. The city of Wells has moved forward with their Rail Park Concept so we anticipate it getting approved as well. Wells has a serious lead who is looking at their industrial park. All stakeholders have met to discuss options as well as the necessary steps to make this happen which includes getting a natural gas line to the area. The strategic rail plan was unveiled and we are working on the initiative. Rail could be a force multiplier for economics in our region. We have been working with a few more leads in the last few months. Silver Lion Farms is planning an expansion to their facility. Sheldon has provided a few letters of support for the Community Development Block Grant Program. One was for White Pine County and one for the City of Ely. Lastly, NNRDA has been reaching out to our legislature in regards to the different resolutions that will surely affect all of rural Nevada and quite frankly, if passed will make our job nearly impossible.
- 2) **RNDC:** Report from Shirley Allen-Kellerman, RNDC, Business Lending Representative. **Discussion:** Shirley commended Michelle Beecher for all the time and effort she puts in at the office. So far in the first quarter RNDC has approved 8 loans totaling \$826,000 with another \$5,000 going to the loan committee
